



MEMORANDUM OF UNDERSTANDING

between

Prof. Dr. **Leonard Azamfirei**, Rector of the „George Emil Palade” University of Medicine, Pharmacy, Science and Technology of Târgu Mures, Romania and
Prof. Dr. **Gall Anthony** PhD, Dean of Faculty (Miklós Ybl Faculty of the Built Environment) Óbuda University
in their effort for

- supporting and further developing good relations between both universities;
- creating conditions for the exchange of students and academic staff and free flow of information;
- and strengthening friendship and good relations between countries

have decided to commit themselves to the following articles of the contract:

Article 1

The contracting parties will support the development of bilateral relations through:

a) supporting and facilitating co-operation and contacts between particular



departments, institutes and departments of both universities;

- b) supporting and facilitating the visits and exchanges of lecturers, experts and scientific workers.
- c) supporting and facilitating the exchange of pedagogic methods and materials;
- d) supporting common scientific projects;
- e) supporting the exchange of information on scientific and research nature and organizing common scientific meetings;
- f) supporting technical and educational upgrading of the workers of both parties.

Article 2

The parties agree to regularly exchange information regarding the development and improvement of teaching strategies and materials with a special focus on architecture, engineering, including building construction engineering.

Concerning research, the two universities will organize exchanges between researchers and teacher-researchers within the frame of common programmes and will reserve a special place for them in scientific manifestations.

Concerning education, the universities will exchange students beginning with the second year of studies. These students will have the opportunity to spend one year or one semester in the partner University.

Article 3

The co-operation of the contracting parties will be based on the principles of equality, general reciprocity and bilateral benefit. It can involve: bilateral coordinated and common research projects, studies and survey, common courses, seminars, conferences and symposia, as well as informal cultural, sport and other activities.

Article 4

The co-operation following from this Contract will be subject to the legislative and judicial norm valid in the country of the respective contracting party.



Article 5

The co-operation following this Contract will be materialised through the realisation of Protocols denoting the subjects of co-operation, its organisation, ways of financing and other essential facts. The Protocols must be endorsed by the supreme authorities of both Universities.

Article 6

- a. The Contract is valid from the date of its signature.
- b. The validity of the contract is five years. After its expiration it can be prolonged by the contracting parties.
